- ▶ Certificate of incorporation (for a newly established company)
- ▶ Copy of PAN card

- ▶ Educational and professional qualifications
- ▶ Detail resume of the individual with all the contact detail.
- ▶ A JPEG photograph
- ▶ Registration fee
